

## Launch of the SSCP Neglect Strategy and Toolkit

Over 140 colleagues from across the children and young people's workforce in Southampton joined the launch event on the 24 March.

The session was opened by Derek Benson, Independent Chair of the SSCP and included contributions from Steph Murray, Deputy Director of Children's Social Care, Jacqui Schofield, Head of Safeguarding and Hayley Winters from the Safeguarding Partnership team.

Question time for the panel was busy. Steph, Jacqui and Derek were joined by Councillor Peter Baillie, Lead Member for Children's Social Care, Simon Dodds, District Commander for Hampshire Constabulary, Alison Philpott, Cross Phase Advisor and Harry Kutty, Headteacher at Cantell School. The panel answered questions and shared their views about why this is so important for our city's children and families.

The main aim is to ensure we collectively share a common approach to neglect, with a common language and use this consistently to make a difference to children and families.

## **Working with families where we perceive resistance or lack of compliance**
